## Why?

Over 100 retired members who completed an NSWNMA survey told the Association they wanted to be part of a retired members group when they are available.

- 4 Midwifery.

And told us they would be prepared, after being informed of the facts:

- 2 Call talk back radio
- 3 Write letters to the editor of local newspaper
- 4 Attend Rallies
- 5 Assist local NSWNMA Branches with campaign and other activities.
