PROFESSIONAL INDEMNITY INSURANCE

Professional Indemnity Insurance includes civil liability cover for members, as well as cover for Coronial Inquests and NSW Civil and Administrative Tribunal matters. The NSWNMA assists with statements and interviews in regard to adverse incidents and will represent members. Where required, NSWNMA can refer a member to NewLaw.

What does the cover provide?*

Professional Indemnity: \$5 million per claim Inquiry Costs: \$100,000 per insured (e.g. for coronial inquests and NCAT)

Public & Products Liability: \$10 million per claim.
